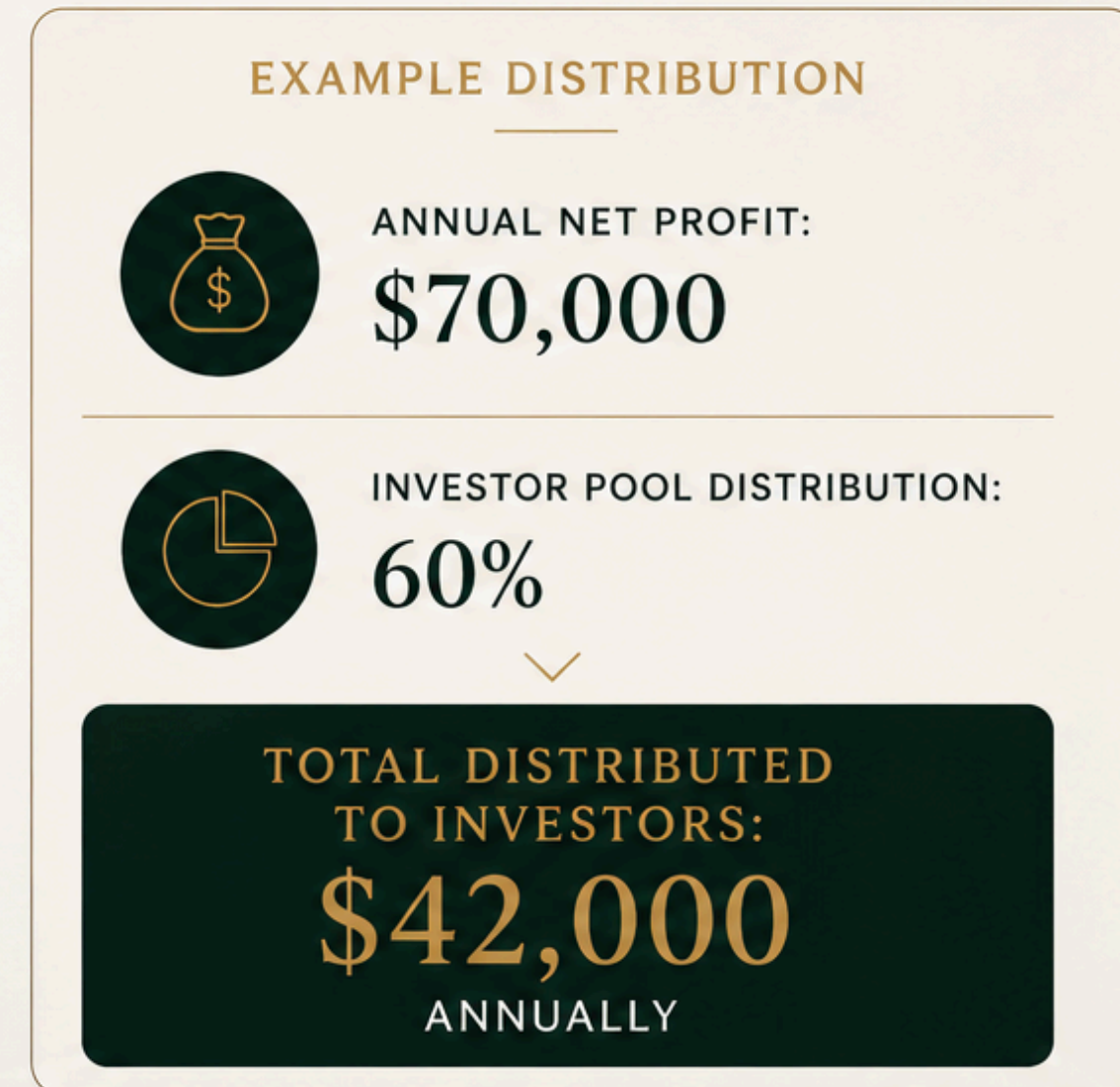
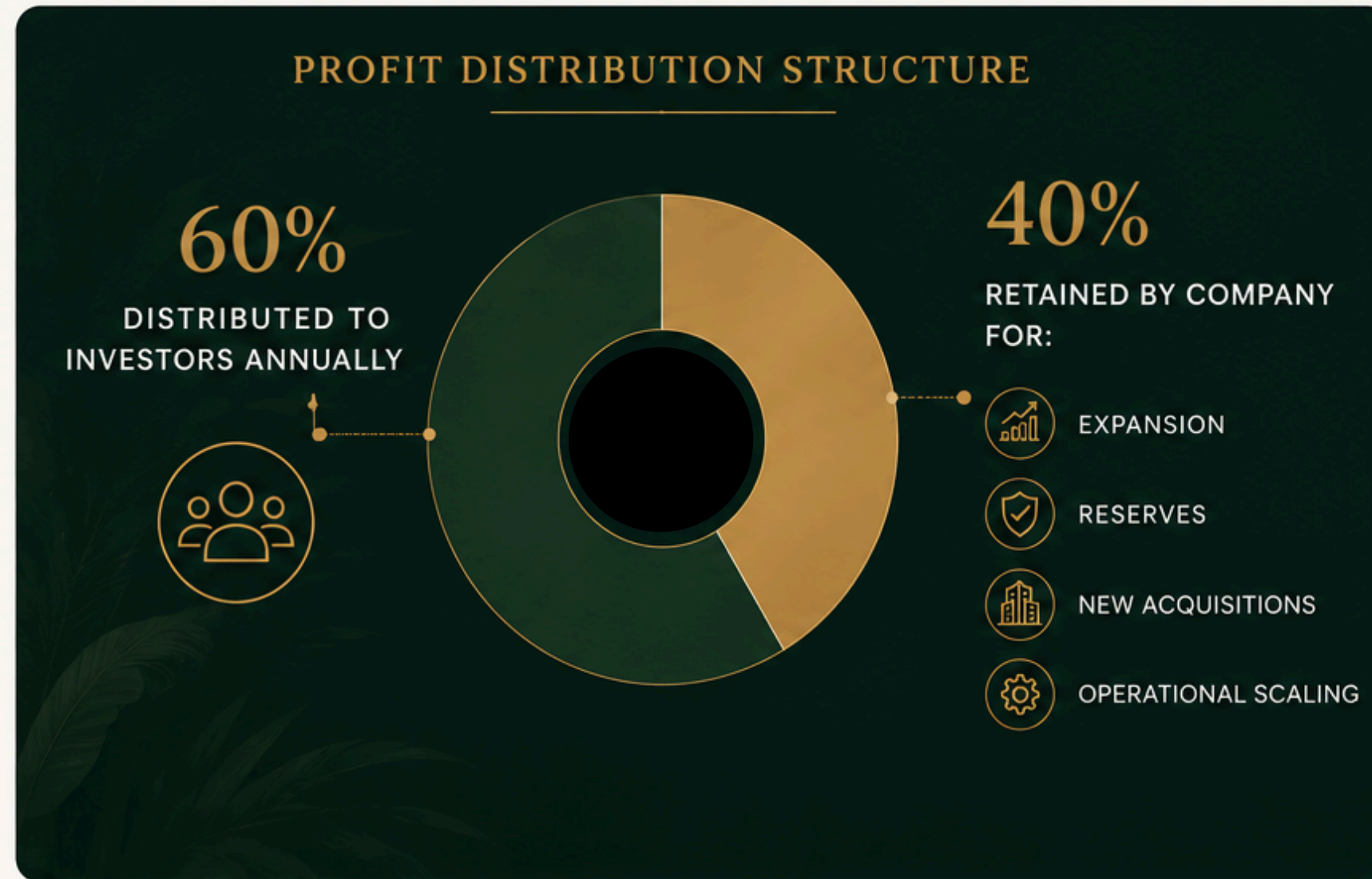

As property values increase, investor equity value grows.





